**American Muckrakers Calls on Julian Beaudion to Withdraw from US Senate Race**  
**American Muckrakers asserts Beaudion is funding personal expenses with donor cash and points to his record of foreclosures, lawsuits against him and bench warrants.**

***“Was Julian Beaudion Recruited to Divide the Opposition?”***

American Muckrakers, a watchdog, and investigative journalism organization with a history to holding scoundrels accountable, today called on South Dakota candidate for US Senate, Mr. Julian Beaudion, to suspend his campaign and withdraw, citing his financial history and significant questions about how his campaign is spending its money.

***“I’ve done a deep dive on Mr. Beaudion’s history in Louisiana and South Dakota, and I can say with certainty, and on the record, Julian Beaudion is using his donor’s funds to pay his personal expenses and hire his friends and family.”*** said David B. Wheeler, President and Co-Founder of American Muckrakers.

American Muckrakers urged Beaudion to step aside and put his finances in order.

***“Mr. Beaudion needs to deal with his personal finances, get a real job, and drop out of this race. If he doesn’t, that guarantees another term for the useless incumbent.”*** Wheeler said.

American Muckrakers is also asking whether Mr. Beaudion's candidacy was engineered to help the incumbent by diverting attention, resources, and votes in this three-candidate race. Given the recent indictment of Sen. Thomas Pischke (R-SD) and the questions surrounding Mr. Beaudion's financial history and campaign spending, South Dakota voters deserve clear answers about the purpose of this campaign, how donor money is being spent, and his relationship with the useless incumbent, Senator Pischke, and his campaign operatives.

***“Did the current US Senator recruit Mr. Beaudion to run, to ensure his gravy train in DC doesn’t end? The evidence points that direction,”*** Wheeler said today.

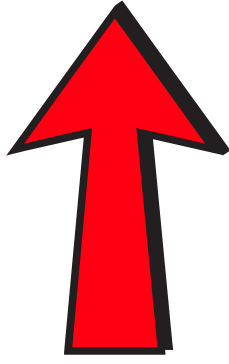
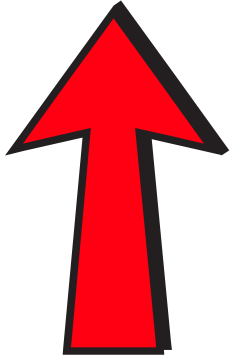
